APPROVAL OF MINUTES

Mr. Julian moved and Ms. Harrison seconded that the Minutes of the October 13, 2021 meeting be approved as submitted. The motion was passed with Ms. Harrington abstaining, as she did not attend the October meeting.

DSHA REPORT – Mr. Young

- Budget public hearing was yesterday. Ms. Casey testified on behalf of COH, along with Patricia Kelleher from NCALL and Sarah Rhine from Housing Alliance Delaware.pport
- Rental assistance via DEHAP continues to be a primary focus. DSHA has increased capacity and weekly payment processing has gone up sharply the last several weeks, to over \$2 M/week. There are currently have over 50 reviewers working on files. The program continues to receive a large number of new cases (not all new households also recertifications for past recipients), upwards of 2,000/month.
- DSHA continues to work closely with JP Court on specific cases again as well, to ensure applications with active eviction filings do not fall through any cracks and that, wherever funds can avoid an eviction, we can assist.
- Additional legal services capacity at the end of 2020 DSHA allocated funding to legal services through CDBG & ESG. Federal ERA funding also allows for "Housing Stability Services" which can include legal services, and CLASI and partners (working together as the Eviction Defense Project) have been putting together an expansive plan to increase legal services capacity. We are in the final stages of working through that proposal with them, and some pieces are already starting, notably outreach and a new courtroom navigators program.
- Additional community navigation/support services last week, DSHA released a NOFA for \$5 million to support Housing Stability Services to help facilitate access to DEHAP and support households who are unstably housed or experiencing homelessness. This will allow for dramatic expansion of our current community partner application support.
- As was shared last month, it is likely Delaware will be subject to some amount of reallocation of rental assistance funds this is not a surprise and many small states which received the minimum allocation are similarly facing this issue.
 - O DSHA is currently working on a Program Improvement Plan required by Treasury and making some program guidelines adjustments to help facilitate distributing assistance.
 - o The process Treasury has laid out is incremental and allows time for programs to continue to ramp up. It will not be a one-fell-swoop large amount reallocation.
 - O Any reallocation will not impact DEHAP and our ability to continue offering rental and utility assistance. We have adequate ERA 1 funding and there is a second bucket of funding, ERA2, that DE has not begun spending and goes through Sept. 2025.
- DDD DSHA launched the Fall 2021 DDD Rebate Round on Monday, Oct 25. There will be approximately \$8.5 million available for Large Project submissions. Applications will be due at the end of January 2022 and we anticipate making the rebate reservation announcements by the end of March. There has been some interest from new investors in the districts, so we're looking forward to a competitive round.
 - One change this round is the addition of a scoring category for coordination with contractors certified by the Office of Supplier Diversity.
 - o Investors may also document workforce development programs for priority scoring.
 - o Information provided by the investors on the level of their ongoing work in this area will inform future emphasis in this and other DSHA funding programs.

• Stephanie Griffin will be moving into the position of Director of Housing Finance. She will be greatly missed in Housing Development, and DSHA will be working on a smooth transition.
