# **Consolidated Plan Process**

- HUD-required planning and reporting process for use of federal HUD funds (CDBG, ESG, HOME, NHTF, and HOPWA) for HUD entitlement jurisdictions
- 5-Year Consolidated Plan (2020)
- 1-Year Annual Action Plan (AAP)
  - Due May 15\* for the FY starting July 1
- 1-Year Report (CAPER)
  - Due Sept. 30 for the FY ended June 30

### HUD Community Development Programs

Program	General Activities
Community Development Block Grant ( <b>CDBG</b> )	Very broad – community development serving low-income communities and households
HOME Investments Partnerships	Affordable housing production (rental and homeownership) and needs, Community Housing Development Organizations (CHDOs)
Housing Opportunities for Persons with AIDS (HOPWA)	Rental assistance, supportive housing for persons with HIV/AIDS
Emergency Solutions Grants ( <b>ESG</b> )	Homelessness prevention, services, shelter Rapid re-housing Homeless System support (CMIS, coordinated entry)
Housing Trust Fund ( <b>HTF</b> )	Affordable housing production, primarily rental, for extremely low-income (<30% AMI) households
Recovery Housing Program ( <b>RHP</b> )	Production of shorter-term (<24 months) housing for people in recovery
