

Substantial Amendment to DSHA FY2015-2019 Consolidated Plan, FY2019 Annual Action Plan and Update to Citizen Participation Plan Available for Public Review

The Delaware State Housing Authority (DSHA) is making available for public review and comment a Substantial Amendment to the **FY2019 Annual Action Plan**, **FY2015-2019 Consolidated Plan** and updated **Citizen Participation Plan**. Public comments will be received from May 13 through May 18, 2020.

The Substantial Amendment addresses the planned use of FY2020 CARES Act funding to the following programs to respond to COVID-19 related needs:

| Community Development Block Grant (CDBG-CV): | \$1,471,924 |

| Community Development Block Grant (CDBG-CV2): | \$3,228,336 |
| Emergency Solutions Grant (ESG-CV): | \$807,114 |
| Housing Opportunities for Persons with AIDS (HOPWA-CV): | \$45,703 |

The Substantial Amendment also addresses the reallocation of \$400,000 in FY19 CDBG funding from homeowner rehabilitation to COVID-19 prevention and response.

DSHA has also made changes to the Citizen Participation Plan to allow for virtual public hearings as public gatherings are currently limited by the State of Emergency related to COVID-19.

The Consolidated Plan and Annual Action Plan serves as the housing planning documents of the State, and as the application for funding to several HUD funding programs. The Citizen Participation Plan illustrates DSHA guidelines for public input on plans, programs implements, and reports on federally and state funded programs.
