



ANNOUNCEMENT OF AVAILABILITY OF FY2026 HOME4GOOD PROGRAM FUNDS FOR NEW CASTLE, KENT, AND SUSSEX COUNTIES

The Delaware State Housing Authority (DSHA) and the Federal Home Loan Bank of Pittsburgh (FHLBank) have established a partnership to provide grants to selected nonprofit organizations to support initiatives in Delaware that lead to stable housing for individuals and families who are homeless or determined to be at-risk of homelessness. The name of this collaborative grant program is **Home4Good**.

As a result of this collaboration, activities previously supported by the Housing Development Fund (HDF) Housing Support grants will now be funded through Home4Good.

Home4Good established funding set-asides for the following activities:

1. Rapid Re-Housing (**up to \$375,000**);
2. Homelessness Diversion (**up to \$200,000**);
3. Homelessness Prevention (**up to \$300,000**);
4. Re-Entry (**up to \$200,000**); and
5. Innovation (**up to \$375,000**).

There is no limit to the number of funding requests; however, approved funding amounts may be different than the funding request. Notwithstanding the foregoing, FHLBank and DSHA reserve the right to redistribute the allocations so that the total amount of awards will not exceed \$1,450,000.

1. **Applicants must submit a completed and electronically signed application package to DSHA by 4:00 p.m. on Tuesday, July 15, 2025;**
2. The Home4Good application is available online at: **<https://www.destatehousing.com/build/community-benefit/>**
3. The Home4Good application process will be an electronic-application process only. The application and required support documentation must be submitted to DSHA electronically to the **[DSHA comdev@delaware.gov](mailto:DSHA_comdev@delaware.gov)** **e-mail** by the above-stated deadline. Applications will not be accepted in any other format (e.g., paper);
4. Required documentation for each exhibit needs to be labeled “Exhibit “X” – “Name of Exhibit”. The application and all exhibits should be combined into a **single PDF** and labeled “Application-Program Name”. For confirmation purposes, please send e-mails with a “**Read Receipt**” request; and
5. Partial-application submissions will not be accepted. Applications received after 4:00 p.m. on Tuesday, July 15, 2025, will not be accepted.
